### Industrial Awards

Most industrial awards and workplace agreements include a requirement for an employer to make superannuation contributions on behalf of employees. This sometimes includes naming the fund or funds into which employer contributions must be paid. In other awards, employees must be offered a choice of superannuation fund under the Federal Government's choice of superannuation fund laws (Choice). AMIST Super is a complying fund for the purposes of the Choice legislation.

You should check the requirements of any industrial awards that apply to your staff.

Superannuation contributions generally fall into two categories:

- A choice of investment options with proven long-term performance.
  - Automatic life insurance and income protection insurance, with no questions asked.
  - Low administration fees.
- superannuation guarantee contributions; and
  - voluntary member contributions.
